2. Your personal data are processed for the purposes of:

- a. conclusion and performance of an agreement (basis: Article 6 sec. 1 point b of the GDPR);
- b. fulfilling legal obligations (basis: Article 6 sec. 1 point c of the GDPR), e.g. issuing and storing invoices, etc;
- c. archiving (evidence) to safeguard the information in case of a legal need to prove the fact (our legitimate interest, basis: Article 6 sec. 1 point f of the GDPR);
- d. possible establishment/submission of claims or defence against claims (basis: Article 6 sec. 1 point f of the GDPR);
- e. our direct offer of products and servises to you (our legitimate inetrest, basis: Article 6 sec. 1 point f of the GDPR);
- f. our direct offer of products and services of our business partners (our and partners' legitimate interests, basis: Article 6 sec. 1 point f of the GDPR);
- 3. For the purpose of the proper implementation of the Agreement, your personal data may be shared with the following categories of entities:
 - a. entrepreneurs providing accounting services (accounting, tax), debt collection, legal, IT services to us;
 - b. entrepreneurs providing postal or courier services to us;
 - c. entrepreneurs providing financial services (e. g. banks) to handle payments;
 - d. financial or judicial authorities, public agencies, public authorities, at their request, to the extent permitted by law.
- 4. Access to your personal data is granted only to persons authorized by the Administrator.
- 5. We do not make automated decisions including profiling.
- 6. Your personal data necessary for the performance of your legal duties will be processed for the duration of the agreement and for as legal regulations (e.g. tax regulations) require the data to be kept:
- 7. You have right to:
 - a. have access to your data and receive a copy of it;
 - b. rectify (correct) the personal data;
 - c. transfer the data;
 - d. erase the data, unless processing is necessary:
 - to exercise the right to freedom of expression and information,
 - to fulfil a legal obligation requring processing under Union law or under the law of Member State to witch the administrator is subject,
 - to limit the processing of data, exept as provider for in Article 23 of the GDPR;
 - the right to object to the processing of data;

- -filing a complaint with the supervisory authority of the President of the Office for the Protection of Personal Data:
